ovember is Model Railroad Month, and it has been a very good month for Division 10. We got off to a fast start at our meeting with an excellent presentation on NMRA Achievement Program by Frank Koch, the AP Chairman. Frank MCR opened by presenting the "Golden Spike Award" to Joe Holbrook and Wendell Greer. who had their layouts on tour in September.

After the program, we toured two more excellent layouts: Tom Brough's HO and David Greer's N. Everyone had fun.

On Saturday, the 13th., our Mid-Central President, Marty Vaughn, came to Lexington with Dick Briggs and Howard Smith Jr.; all three are Master Model Railroaders from the Columbus, Ohio area. They worked all day, judging Achievement Program projects for David Greer, Joe Holbrook and Wendell Greer. They liked what they saw!

Joe qualified for Master Builder, Motive Power, one of the most difficult categories, and for five merit awards in the Structures category. Just a little more work and he will have at least two other certificates.

## In Memoriam Fred Welch, 72,

died November 13, and was buried November 18 in Liberty, Ky., his former home. He was a retired bank examiner, an Army veteran of World War II., and the widower of Virginia Price Welch.

Fred was very active in model railroading and railroad photography. served President, Board Treasurer and Member of the Bluegrass Railroad Club, and was a member of the Bluegrass of Railroad Museum and the NMRA. Many of excellent black and white photographs of vintage steam are on display at the nightly Bluegrass RR Club exhibit at "Southern Lights" at the Kentucky Horsepark until Christmas.

Anyone who knew him will not soon forget "The Bosshogger."

David Greer qualified for the "Golden Spike Award," Master Builder Scenery, Model Railroad Engineer-Electrical, and four Structure merit awards. I'm also pleased to announce that David has accepted the position of AP Chairman in Division 10, with Wendell as his

We are now incorporated and we have a checking account. We hope to have bylaws to share at our next meeting.

Mike lives at 922 Mason Headley Road in Lexington, with his wife Robin and their dog, both of whom tolerate railroaders pretty well when we gather there for an occasional get-together.

He is originally from Johnson City, TN, where he developed a strong interest in the Clinchfield, and came to Lexington to work for Lexmark International as an engineer (not the railroad kind - you wish!)

Mike has interests in 8 other Southern & Eastern roads besides the Clinchfield. His major project right now is to complete the basement, so he can start a multi-deck layout of a proposed but never completed Clinchfield line from Ashville, NC to Kona, NC. In the meantime, he's collecting, painting and detailing the locomotive and car roster. The lack of availability of Clinchfield models started Mike on his part-time business, Coal Country Carworks, researching Clinchfiled freight car prototypes and producing custom factory car runs, of which to date he's completed four car types in multiple numbers for a total of 20 unique models. Mike is also interested in and models WWII military vehicles, and is a member of two organizations associated with that interest. I guess you could say he's a 'cross-addicted' modeler.
