PROPOSED POLICY CHANGE

Effective February, 2002, if there is not a substantial increase in donations, we will have to institute a subscription charge of \$10 per year to receive a mailed copy of *The Lantern*, as discussed at the October General Meeting. The objective is threefold:

2. Generate some revenue for Division 10.
3. Reduce our operating expenses.

President's Message by Marty Vaughn

There have been some tragic and significant events in our country since the last of these columns. Our country has lost some of its innocence and perhaps some naiveté. As I write this, the number of dead and missing is over 6,000 but probably not complete. While these terrorists found a temporary weakness they also brought to light some of the enduring strengths of our country. These strengths have been demonstrated from the beginning by the rescue workers in New York and Washington D.C., by the passengers of United Airlines Flight 93 and by the outpouring of blood donations and aid to the victims and their families. Sometimes we forget our strengths. Those with the terrorist mindset will never understand those strengths, but they will come to know the impact of those strengths over time.

As you all know by now the NMRA has increased dues effective 1 September 2001. I have heard from a number of you about this increase. Most of you, that I have talked to, aren't happy with the increase but understand why it is necessary and are going to continue in the NMRA. A few of you have told me that this increase does cause some financial problems but you are going to stay on as affiliate members. And a very few that I have talked to are going to leave the NMRA.

We all have to make our own decision on what to do about our membership and whatever you decide, I support your decision. I hope you will remain a member of the NMRA. I decided to convert the multi-year membership I sent in July into the down payment on a life membership.

There is only one complaint I have heard that bothers me. Basically this complaint is that the NMRA doesn't do anything. In the most striking case the member made that complaint and went on to say he had never attended a National Convention and had never attended a Regional convention. He said that the AP program was a waste and too much money was spent on these "contests" for a select few and he wouldn't ever waste his time on that. He didn't say if he uses digital command control or not so I don't know if he got any benefit from the newest NMRA standards program or not. While he didn't come out and directly say it, he left me with the impression that he didn't bother to attend the meetings of the Division where he lived either. It became apparent that even if there were NO dues this person wasn't getting his money's worth.

His complaint about the AP is one prime example of this. I'm proud to admit I have earned an MMR so while you might accuse me of being a bit biased toward the AP I have also participated and know about the program. There are no "contests" in the AP. In fact there are nearly as many certificates that are based on service as there are modeling. If you aren't interested in sharing and improving your modeling you can still participate in the AP. The organization at all levels can always use Volunteers, candidates for Officer who are willing to help lead or Authors who are willing to share their efforts with the Bulletin, the Region web page or a Division newsletter. As for the modeling certificates, you can complete them all, become an MMR and never enter a contest. I guarantee you that if you do it will improve your modeling and probably open up aspects of the hobby you'll enjoy but never thought to try on your own. The NMRA is no different than any other organization; you're not going to get anything out of it if you aren't willing to put something into it.

I hope you caught the mention above about articles for the web page. There have been some problems getting the web page running smoothly, but hopefully we have over come that now. We finally got the text for the first layout uploaded and by the time you read this Jim

Hodde's layout should also be up and viewable. We are also interested in modeling articles, with pictures for the web page. If you don't feel comfortable submitting your first effort to the Bulletin then give us a try. Send the article to me, complete with pictures and we'll load it to the web site to share with everyone. Photos, slides and digital images are all acceptable. If you can send your write up on a disk or email that would be best but we will type it for you if you don't have access to a computer. You'll gain experience writing an article and Author points in the AP as well. We also have room for more layout tours on the site. Send your layout tour photos to me and remember to include captions for the photos, a photo of yourself, and a little information about your layout and your personal modeling interests. We are also getting the events page up and running. If you have a Division event coming up, please send the information by email to Ivan Baugh at: iv-baugh@home.com. In the meantime Ivan will take the events listed in your Division newsletters and use those to post the schedule. We will try to keep this updated monthly with a 90-day window of events. In the meantime, if you have any questions, problems or just want to talk model railroading, feel free to call, write or send me email.

Trustee's Message by Mike Brestel

The last time I wrote to you was just before the St. Louis Convention. I told you about National's financial crisis, which many of us in the Mid Central Region had seen coming for a long time, and I promised to let you know what we did in St. Louis to help resolve our problems.

This is probably old news to you by now, but the BOT action of immediate concern to the most members, was that we raised the dues from \$34 to \$45 per year for a regular membership. Something that has surprised me since the increase is that I haven't heard nearly as much negative about it as I expected.

To those who are not sure whether an NMRA membership is worth \$45 per year, please consider this: My wife and I went out to dinner and a movie a few weeks ago. The movie cost about \$18 for two tickets. Small popcorn and small drinks cost about \$10. Dinner, with no alcohol, cost about \$30. The babysitter was free, but usually costs about \$20.

So a four-hour date one evening cost us about \$58. If we had to pay for a sitter, it would have cost about \$78, and the movie was lousy! When I compare the cost of a year's worth of NMRA fun, fellowship, and educational opportunity to the cost of a single evening's questionable entertainment, the NMRA wins, hands down. When it comes time to renew your membership, please think about what the NMRA means to you and your modeling, and consider that the price of almost everything has gone nuts in the past few years.

In addition to acting to raise revenue, the BOT also worked to cut expenses in nearly every area of our operations. The intent of these changes was to return us to a balanced budget by the end of August, 2002, with some left over to repay what we were forced to borrow this year and last. Thanks to those of you who have given me specific suggestions for returning us to a balanced budget. Every one of your ideas was considered, and many of them have been adopted.

In St. Louis the BOT also voted to move forward on the Long Range Plan that we hope will return the NMRA to its core functions and increase its relevance in today's modeling world. The only part that did not pass was the effort to reduce the size of the BOT. I guess I should not be surprised, what group will volunteer to reduce its size? But I was still disappointed. Only five trustees out of 17 voted to downsize the BOT.

The rest of the Long Range Plan will take some time to implement, since it involves rewriting large portions of

the constitution and by-laws. I expect to see the first concrete results of this effort at our meeting in February, and we will proceed from there.

On the financial front, our new treasurer, George Schmid, found the size of the cleanup job needed in Chattanooga to be too much for his available volunteer time. Among the hundreds of NMRA volunteers around the country and across the world, all of whom deserve our thanks, there are two other individuals whose efforts I specifically want to commend to you. Allen Pollock and John Roberts inherited a situation that was totally beyond their or anyone's expectation when they took their current offices. They have devoted countless hours to our organization, often at their own expense, and there is no end in sight. When you have the opportunity, please let them know how much you appreciate what they have done for all of us. As you can imagine, the pace and volume of BOT business has dropped off considerably since the tragic events of September 11.
