Message From The Superintendent

It has been two months since our last newsletter and a lot has happened in that time. First let me thank Renee and Ray Grosser for the great outing at their place in June. The weather was perfect. The food was great. As usual the trains were a real treat to see again and it was fun finding all the new additions to the layout. AND having the bonus of the steam tractor running was really fantastic. Thanks again to Ray and Renee and to Mark Jordan for running his Frick steam tractor.

In July we had the National Model Railroad Association's National Convention in Cincinnati, Ohio. For those of you who did not attend the convention, let me tell you it was great. I was only able to attend for 3 days of the 7 day event. But in those 3 days I made it to over 16 one hour clinics and spent at least 7 hours on the show floor. This was my first National and it was everything I had expected it to be. There is a full description elsewhere in the newsletter.

On August 6th we will have a NMRA judging event at Pete Birdsong's. Directions and an entry form will be found enclosed with this newsletter. As far as I know, this is the first open event of this kind to be held by Division 10. The primary purpose for this meeting is the judging, by NMRA national standards and rules, of our modeling efforts. The judging process helps modelers find out what they are doing right and where they need improvement. If sufficient points are awarded to a model it can be used by the modeler to meet some of the re-

quirements necessary to achieve Master Model Railroader status.

An event such as this is also very useful to those who are not entering a model but just want to see what it is all about. I highly recommend that all of you consider attending whether or not you have something to enter. It promises to be a great afternoon!

This month, August 7th to be exact, we will visit Danville, KY and see 3 great layouts there. We will start at Bob Lawson's. A map is included in this newsletter. His layout will be open from 1:00 on. There will be snacks and drinks available. We will have the Bring 'n Brag contest and the display of the previous day's NMRA judging event upstairs in Bob's layout building. The Bring 'n Brag contest will close at 2:30 so if you have an entry please try to get it there by 1:30 and if you want to vote, don't miss the 2:30 deadline.

From Bob's you can go to John Bowling's and/or to Robin Grider's layout(s). Maps to both will be available at Bob's. All three of the layouts on this tour are good examples of how to do it right.

Bob Lawson's work has been featured in 'Model Railroader' magazine and was the subject of a volume of Allen Keller's "Great Model Railroads" video series. Bob's layout depicts the Southern railroad in a mountainous setting with many very detailed scenes. Upstairs Bob has many different buildings and railroad structures on display. Many are in the process of being completed and Bob will be available to explain his modeling techniques using those items.

Robin Grider's layout is a modular HO

railroad and is housed in the Danville Model Railroad Club building. It features a very complex yard, lots of scenery and great running trains. Robin is always gracious enough to bring his layout to our Division train show and I hope he will bring it again this year. Robin will be available to answer your questions about how to keep your track and trains in good running condition.

John Bowling's L&N railroad takes up the greatest part of his very large train building. The layout features three main lines and many yards, factory sidings, bridges and tunnels. The layout has working signals for all three main lines and working crossing gates or cross bucks for all railroad crossings. In the last year John has added or replaced over 20 structures on his layout. Most of these new buildings are complex structures such as a tannery, a furniture factory, and an old mill. Plans have been made to feature John's railroad in a future issue of 'Model Railroader' and for Allen Keller to make it the subject of a new volume for his "Great Model Railroads" video series. John will be available to answer questions about all the features of his layout and how he was able to expertly make so many perfectly seamless scenery changes to a finished layout.

Don't miss this tour. Wives and friends are welcome. If you need a ride please contact one of the officers whose phone numbers and email address are in this newsletter.

The next big event to think about is our Division 10 Fall Train Show. This year it will be held at Turfland Mall on the weekend of November 12th. We are currently planning a two day show.



Larry: I got a friend and Christmas is in six months.


Rivets: Larry, I got enough junk of my own. I don't need yours.

2005 NMRA Convention - Cincinnati

I had the privilege of attending my fifth national NMRA convention, July 3-9. The organizers put together a wonderful feast of layout and prototype tours, clinics, and contests. There was the usual frustration of too many good things going on at the same time. For this convention, I decided to attend clinics since I have learned so much from them in the past. I did hear many good reports of the layout tours, however. There is a lot of model railroading activity in Cincinnati and many great layouts to see.

It was possible to attend seven clinics a day. As the week went on, I found I had the stamina for six: two in the morning, two in the afternoon, and two of three offered in the evening.

Since I had just torn up my layout and taken it to the landfill, I was interested in clinics on layout planning. I attended three: Prototype Layout Design, Practical Layout Design, and the Ten Commandments of Yard Design. Many good ideas were offered that will help me avoid many mistakes on my new layout.

There were five presentations on layouts by well known model railroads. Tony Koester, a columnist for Model Railroader, gave a slide presentation on his new NKP St. Louis subdivision. This will be a huge two level layout, well over twice the size of his old Allegheny Midland. He is attempting to model an area where he once lived by reproducing track plans and buildings.

Allen McClelland reported on the progress of the new version of his Virginian and Ohio. I bought a box car and a tank car lettered for his railroad at the NMRA Company Store. Both of these layouts are still at the track laying stage with very little scenery.

Gary Hoover also started a new layout, an attempt to reproduce an area of the Santa Fe in 1951. The 1950's seemed to be the preferred modeling period for many of the clinic presenters. It was a time when you could have both steam and diesel and be prototypically correct. He had some stunning scenery.

Another effort at prototype modeling was David Barrow's Lubbock Industrial District, a new version of his Cat Mountain and Santa Fe. It is primarily a switching layout, reproducing operations in Lubbock, Texas. A similar presentation was on Chuck Hitchcock's Argentine Industrial District which is based on a Kansas City prototype. All of these were remarkable layouts. One interesting note was that many of these layouts used manual turnouts and picks for uncoupling rather than magnets. That seemed to be a heavy preference.

There were several clinics on operation. Those that attempted to be prototypically correct involved huge amounts of paperwork which I personally would not enjoy. The use of card systems seemed to be the preference.

There were a number of good clinics on scratchbuilding, weathering, using styrene, and scenic detailing. Dean Freytag held court every day in the lobby area discussing his work in building steel mills. There was always a group of people around him. One good clinic on superdetailing cheap rolling stock presented some good ideas.

One of the popular features of a convention is the contest. The models to be judged were just amazing. I attended a clinic on how to be a contest winner and one on judging. They did stir my interest in entering a contest, but the standards are very high. By pure chance I happened to eat supper with one of the winners, an O Scale model of a Hooverville during the Depression era. It won a number of awards in various categories.

There were clinics on signaling, most of which I did not understand, being such a lowtech person. One on running your layout from your computer was a disaster. The presenter couldn't get the program to work very well and could not communicate clearly. Two I attended on traction modeling were very good.

It was a very worthwhile convention. I saw some old friends and a few of our guys from Lexington. The National Train Show at the end of the convention was much better than last year's at Seattle.

The convention will be in Philadelphia next year. It is a great experience to learn from outstanding model railroaders and to meet people who share your interests.


