A Visit to MCR Division 9

Pete Birdsong, Ron Kercheval and Bill Paulsell traveled to Division 9 (The Coal Division) on Sunday, July 15, to visit the layouts of three Division 9 members. The trip was a reciprocal planned as part of a Division 10 - Division 9 tour exchange. Division 9 visited with us at the Eubank outing with the Grossers in June.

We left around 8 o'clock Sunday morning, and arrived in Charleston at the home of Bob Weinheimer, Division 9 Assistant Superintendent, 11:00. Bob had also hosted a meeting of the C&O Historical Society that day, but that group had largely left by the time we arrived. Bob showed us around his Pennsylvania Southern HO layout, explained how his monthly Operations Sessions work, and had us run a coal drag, complete with helper service, up a long, steep, curving grade, after maliciously informing us that the coal loads were "live" - they were all loose loads, that they would spill all over in a derailment/overturn, and that they'd never yet had one turn over!

We completed the run, derailing only the caboose, but it was a scary situation. Afterwards we immediately left for lunch at Wendy's to calm our nerves, and then to Gallipolis, Ohio: home of Lin Young, the Division Superintendent, and his Grafton & Greenbrier HO layout - site of an Operations Session every Wednesday night. There, we were treated with another invitation to run trains, again with helper service, but now also including a trip up a blind helix with a 2 3/4% grade in addition to the live loads!

Larry: Somebody will be there. Let's take off tomorrow, Rivets.




