The Mid-Central Region convention in Charleston, W. Va. was a good event. It was well organized, well attended, and ran smoothly. The hotel was excellent. Two hundred twenty-one people were there. Thanks to Bob Weinheimer and his group for all their hard work.

Division 10 was well represented. Pete Birdsong, Lou Jaquith, Brian Jones, Bob Lawson, Fred Pymale, Larry Smith, and myself represented our club. Lou and Larry brought their wives along.

As with all conventions, some clinics were better than others, but I enjoyed all the ones I attended and, as usual, learned new things. Pete Birdsong presented two clinics on logging.

The regional board meeting was pretty routine. It was reported that the 11 divisions in the region lost 22 members last year, although some divisions reported growth. Our latest report from headquarters listed 50 members, half of whom we never see but would very much like to have at our meetings. That seems to be the situation with all of the division.

The next convention will be at Geneva-on-the-Lake in northern Ohio April 28-May 1, 2011. Three of the northern Ohio and Pennsylvania division are bidding to host the national convention in Cleveland in 2014.

Pete, Larry, and I served as judges in the contest room, which was an interesting experience. We all have previous training as

judges. The NMRA has rather exact regulations for judging, and it was a good experience to work with them.

Pete won two Merit Awards for super detailing locomotives. Those are not easy standards to meet, so we congratulate Pete for fine work. Naturally, he did not judge his own models. The three of us judged only the scratch building aspects of the models. Other group judged construction, detail, conformity, and finishing and lettering. That means that five different groups of judges judged each model. Judging is a thorough process.

We will not meet again at Central Christian until October. Meanwhile we will take trips to Danville in June, Eubank in August, and Cincinnati in September. More information on the latter two will appear in future issues of the Lantern. We will follow our usual practice and not meet in July.

## Bring and Brag

Our meeting in May was the last month for Bring and Brag for this season (2009-2010) and we had a great showing of models. We had a total of six. My thanks goes to those who brought in models for the rest of us to examine and admire, and then for us to judge. The topic was non-revenue cars and passenger cars. We combined the topics for the last two months due to our June layouts tour in Danville.

Lou Jaquith brought in a  train which featured an engine, a gondola containing rail, and a caboose. Lou built or kitbashed all three cars adding many extra details before weathering all the cars with paint and powders. Pete Birdsong brought in a couple models, one which was a water tender (or car) and the other one was a tool car, which he built from kits and added a lot of extra details to both. The purpose of the water tender was to make water available for a number of purposes on a logging railroad. After painting the models, Pete had weathered both with Doc O'Brien powders. Don Burris brought in a nice Santé Fe caboose in G scale. Stew Winstandley had a model of a **MONON** heater car which he converted from a troop kitchen car and then added extra details. The purpose of this type of car was to furnish needed heat and power to passenger cars when not con-


