Bring and Brag

The March meeting was the time for persons to bring in their dioramas to show what they had done and to have them judged. Because of the dioramas, there was originally not going to be time to conduct a Bring and Brag session. However, after some discussion, it was decided to include Bring and Brag with the diorama judging with a variation of the popular vote. It was thought that the members would like to be asked to vote for the diorama they liked best and then for their second favorite diorama. Now that we were going to have voting, yours truly had to devise some way to turn these choices into some number to represent all the choices. It was arbitrarily decided by me to have each number one choice be worth 5 points and the second place vote to be worth 2 points. There could have been another set of weighing values, and if you have one, please contact me with it if you wish.

All the dioramas were very nice and it was obvious there was a lot of work done to make them as accomplished as they were. From looking at results of the popular voting, the two dioramas brought by John Bowling were very popular. Between the two, the dioramas collected 12 favorite votes and 8 second favorite votes. It goes without saying that both dioramas were very good. John's Wrisley Bonds and Linens diorama had a total of 43 points, and the other diorama brought by John Bowling received a total of 33 points. This was out of grand total of 119 available points. The other points received were: 18 for Pete Birdsong, 15 for Stewart Winstandley, 8 for Lou Jaquith and 2 for Bill Robbins. Thanks to all of you who brought in a diorama and those members who voted in the popular vote.

It was also decided that these points for the popular voting would be translated into Bring and Brag points. Since the maximum number of points one could receive for a single Bring and Brag entry is 30, a total of 30 points were distributed among the persons who entered the diorama contest in proportion to their share of the popular vote. For example, the diorama from John Bowling of the Dant Mill obtained 28% of the popular vote (33 points of the total possible of 119), so John received 8 Bring and Brag points computed as .28 of 30 points. In a similar fashion, the other diorama from John earned 11 points. Other Bring and Brag points were: Pete Birdsong with 5, Stewart with 4, Lou Jaquith with 2 and Bill Robbins with 1. The updated standings below reflect these additional points.

The Bring and Brag topic for April is Trees and Painted figures. You can bring one or both. George Campbell showed us how to paint figures at the February meeting and Pete, Bill, and Lou showed you how to make trees at the March meeting. So, let's go and make some figures and trees! The last month for Bring and Brag will be May, and the topic for that month will be Weathering.

The rules for Bring and Brag are on our website for Division 10, MCR. If you have any questions or comments, please contact

yours truly, the Bring and Brag chairperson. Any ideas for future topics for Bring and Brag are always welcome. We'll begin a new year in August.

Fred's Diorama Report

David Greer, one of the best modelers I have ever known, once said "Fred, the world is not flat and straight is boring". I've never forgotten it! As a result, when the 2nd. Annual Diorama Program was announced, the following suggestion was made: "A foam base is recommended. It will permit you to demonstrate the use of water on your entry. A river with a bridge, pond, ditch, culvert or waterfall will add interest to the scene. Elevation, use of rocks, trees, and people will also be judged for their realism". We had seven good entries that incorporated many of these features in their Dioramas.

The judges were Ray Grosser, Bill Paulsell, Larry Smith and I using a modified NMRA form with a total of 100 points possible.

1st and 2nd place winner was John Bowling with a total of 79 points on both dioramas. The South River Model Works struc-



tures were beautifully built and subtly weathered by John on both of his dioramas. The buildings had lights with lots of details and people doing typical work in the scenes. South River kits are made in New England and usually have rivers to power the mills and factory equipment. John's rivers were not straight but meandered thru the scene which added a lot of interest

to the water and dams. The roads were excellent and the trucks added to the over all realism. John's river rocks were wonderful. Second photo is below this report.

3rd place was Lou Jaquith with a total of 78 points. When I looked at Lou's small but exquisite diorama I felt I was looking at a real place instead of a model. The realism was incredible! His large scratch built trees were outstanding as were his rocks some of which had been hand carved. The road, crossing and trestle



were all extremely well done. The variation in color and texture of his ground cover was outstanding. The grass really was greener below the privy!

4th place went to Pete Birdsong with a total of 76 points. There



was a lot to like on this diorama. The variation in the size of stone on the gravel road was outstanding and very realistic. The detailing and weathering of the engine and rolling stock was the very best. His large beautiful scratch built building has already qualified for a well deserved merit award and was a major focal point in the scene.

The great structures he acquired from Bill Hammer also added lot of details and realism to the diorama.

5th place was Stew Winstandley with 57 points. His very nice Z-scale diorama featured four laser cut structures that were extremely well built. The waterfront structure on the pier and the boat added a lot of interest to the scene. The curved roads and fence were a very good addition to the overall design of this diorama.



6th place was to Tom Krill with 56 points. I think this was Tom's first entry and it was a great start. His water was excellent and his scratch built bridge was very well done. The people, horses and handcar were also beautifully painted. I'm looking forward to seeing Tom's entry next year!

7th place was Bill Robbins with 45 points. Bill had a very unique diorama. All of his buildings were hand laid bricks something most of us would not have the patience to do. His wagons, people and the detailed interior of the passenger car were all very nicely done.



Everyone who participated was a Winner! You learned some new modeling techniques and built something you should be proud of. As you continue to stretch your modeling skills and learn from others you will be even better next year in our Third Annual Diorama contest.
