Weathering Tips, by Lou Jaquith

Weather affects everything outside. We weather our layouts, rolling stock, and engines to mimic nature. It is a personal preference how much to do. My favorite type is dry weathering, using one of the commercial products such as Doc O'Briens or Bragdon Powders. These have an adhesive component and stick better than pastel chalk. If not handled much, no overcoat is needed.

The most important aspect of this process is to have a good finish on your models. Be certain there is no blush under your decal film. An overspray of Dullcote will <u>not</u> hide this. For powder weathering, a dead flat finish is best. Testors Dullcote is my choice, but as long as it is flat, it's OK. I find that a good make-up kit provides the best tools for dry weathering. Most contain a small stiff brush, a large brush, and various sponge type applicators.

Start with observing what you want to duplicate. Note how a rail car, structure, etc. weathers. An overall coat of a color close to the color of the car will fade lettering. Then use dust or grime to replicate rain and road splash. Note car ends -a vertical pattern in line with the wheels often is present. Rust streaks can be added. Rust is good on truck frames. Car or locomotive roofs can have a coat of grimy black - more for steam era, less for modern cars.

On bridges I use Rustall, now called Rust 'N Dust, a liquid product from Micro Mark. It has clear instructions. Good Luck! Experiment! With dry weathering, if you don't like the result, wash it off and try again!

I was impressed with the other submissions since they showed a lot of work and effort that had gone into them. The clinics must have played a role in all the fine work which was on display. I did not have any figures with my trees but I probably should have included some since I stated the topic was Trees and Painted figures. I hoped everyone enjoyed sharing their models with us.

After adding up the scores for Construction, Detailing, and Finish & Lettering from the scoring sheets submitted, the results were close to what was announced at the meeting. At the meeting, I added up all the scores in my head, and then later at home I put the raw scores into an Excel spreadsheet and let the computer do the adding and averaging. Let's finish the season with something to transform your layout. What could be more appropriate than our first item -



Turn right and then right again onto Knight Ct. Park in his driveway, if space is available. You may park partially off of the street in Anthony's yard, but DO NOT park on the grass across the street.
