Bring and Brag

March was the month for the diorama contest which was judged by Fred and Ray, but Bring and Brag was certainly involved with the scoring results and the popular vote for your favorite diorama. My first reaction on seeing all the dioramas was that there sure was a lot of good modeling going on. All eight dioramas looked good and I thought some were very good looking. Many members expressed how good the dioramas and the modeling looked.

The diorama contest has direct implications for Bring and Brag in a couple of ways. The scoring points from the judging of Fred and Ray is added to the Bring and Brag points. The diorama judging was as follows: Bill Paulsell with 80, Pete Birdsong with 39, Stew Winstandley with 57, Bob Ferguson (Amour Meat Packer) had 40, Bob Ferguson (Neighborhood) with 76, Bob Ferguson (Moonshine Mansion) had 68, Rick Cobb with 83, and Bill Robbins with 48. In addition, we had a popular vote for your favorite diorama as voted by the members, which resulted in Bring and Brag points. Of the 14 popular votes totaled, we had a tie for first between Stew Winstandley with his "Z-country" diorama and the diorama called the "Neighborhood" by Bob Ferguson. For second place we had a three way tie between Bill Paulsell with his "Town with Trestle", Bob Ferguson with his "Amour Meat Packer" diorama, and Rick Cobb who brought the "Out of Gas" diorama with the exquisitely weathered L&N boxcar. I had originally thought I would have a first, second, and third place worth respectively 10, 9, and 8 points but the results of the popular voting revised my thoughts. I decided to add all the points together and add one more to avoid fractions, and give each first place winner eight (8) points, and each second place winner four (4) points.

In May, we will have Bring and Brag in the church before we go to Keith Wiseman's. The topic will be a scratchbuilt model, either a structure or a car. In June, the topic for Bring and Brag will be a photo contest of photos taken by our members. There will be two categories for photo en-

tries. One category will be a prototype photo and the other will be a photo of a model. You can enter either one or both. I know some of you like to take pictures, so hopefully we will have another good turnout. We will have a popular vote by the members for each category. A maximum of one photo will count for each category. I plan to have a first, second, and third place worth respectively 10, 9, and 8 points for each category. June will be the last Bring and Brag month for the 2011-2012 season.
