## Superintendent's Report

it's that time of the year – Election of Officers. We do this every even year. I've appointed **Rick Cobb**, our past Superintendent, to head the Nominating Committee for this October's election. We have a candidate for Assistant Superintendent, **Jeff Hedges**, and for Secretary, **Paul Southgate**. Running for a second term for Superintendent is **Bob Belt**, and for Treasurer is **Alan Bourne**. We (Division 10) really have an urgent need for some organization changes. It seems that our 'Org Chart' is not fully describing our current activities. **Bruce DeMaeyer** and I have had several discussions about revisions, and those will be coming in the near future. Before anything is changed, we'll have a Board of Directors review.

There are a couple new directions I'd like to follow for 2018-2019, particularly in the focus of meetings and tours. First of all, I'd like to get some more clinicians from outside

our division. My target is those who have presented clinics at the Regional Conventions. If we can bring in 3 or 4 a year to supplement our home-grown clinics I think it would fire up some more interest in the meetings. The thought is to focus on modeling – mainly to get the benefit of their expertise. We did this a couple years ago. My omission for not pursuing it further. As far as tours – I think it would be a great idea to revisit our local member's layouts to view progress since the last time we were there. Not only that but to also combine the meeting clinic and tour into one afternoon's session. It's nice to do a Saturday visit to an out of town model railroad but that really commits two weekend days a month. Also, the 'away' tours don't seem to attract as many members as the in-town visits. Some of us seem to go anywhere but others may object – too many times away! Back to the meetings – I've tried to keep the business to a minimum but there has been some grumbling – particularly on my last Convention report. I'll do that in *The Lantern* following the Convention. Let's get back to the real reason we're modelling – to have FUN.

Here's another item, the B&B schedule. I admit that it was a trial to change the format – and it didn't work out very well. How many of you actually spent time looking at the items presented? Let's go back to at least part of the old format. I've asked **Bill Robbins** to prepare 1-2-3 slips and hand them out to everybody attending a meeting, starting in September. Then everyone votes and we'll do a 'People's Choice 1-2 3' at the end of the meeting. I'll still ask everyone who brings a model to say a few words, and I hope to publish a schedule of B&B for at least 6 months in advance. For example, this September's theme will be 'cars' – any type or size. October will be any 'structure'. Once we get a schedule, we'll have more specific targets. OBTW, I'd like to do one in December with the 'what's going to the next Regional


## In Recognition...

## Division 10 T-Trak Update

Bruce DeMaeyer has begun attending T-Traks information meetings around the Region. On the weekend of July 14-15, he drove over to St. Albans W. Va. to visit with Division 9. They have had an active T-trak group since early this year. They are the creators of the Special Interest Group (SIG) idea, have organized themselves with that idea, and have begun building modules. Bruce took two of our modules along so he could show them how our modules and theirs could be joined into a larger layout. After the formal meeting (which featured a great clinic on painting backdrops), a meeting of the SIG took place and the layout was constructed, tested and operated for the first time, all very successfully. Division 9 is making great headway in T-Trak. We will be joining layouts with Division 9 when we both go to the Morehead 1st Annual Model Train Show on Saturday August 25 in Morehead, Ky. We will also be joining together on September 15 for our Second Annual Trains Day at the Library at the Tates Creek Library. Put these meetings on your calendar so you can see us in operation.

The next day Bruce continued north to Morgantown, W. Va. where Division 2 was holding a "remote" meeting. They were not very knowledgeable about T-Trak so the focus with them was to talk more about the concepts and advantages of the modular idea. At first there was just quiet listening, but then the concepts began to formulate understanding and the discussion turned into a serious exchange of information. Division 2 is sponsoring the 2020 MCR Convention in Pittsburgh.

On Saturday, July 21, he drove over to Louisville and Division 8 where Bruce put on a clinic "Organizing for T-Trak". As you all know they are very aware of T-Trak but as a Division they are not officially involved. The presentation was intended to generate ideas on how they might formally institutionalize the idea by forming a SIG inside the division. The meeting went very well, the super agreed with recommendation and possibly that group will formulate a SIG sometime this fall. Both Joe Martin and Nick Coates attended the meeting.

Bruce's next visits will involve meetings with the Miami Valley Division 3 in Dayton and Division 7 in Cincinnati in August and September. He would also like to get up to the new Alleghany Western Division 12 in the northeastern part of the region, as they to are forming a SIG and they also have modules that they are beginning to take to shows.

All of this effort is focused on creating a large assembly of member T-Trak modules and to bring them to the 2019 MCR Convention in Boardman Ohio on May 2-5, 2019.
